

**MEETING MINUTES  
POPE COUNTY PLANNING ADVISORY COMMISSION

The Planning Advisory Commission convened in regular session on Thursday, December 17, 2020 via telephone conference call in an effort to comply with MDH recommendations issued with the declared Peacetime Emergency in response to the spread of COVID-19 (coronavirus) in MN.
